BOARD OF COMMISSIONERS

William "Fritz" Crosier, Chief Deputy of Engineering, Engineer's Office, offered a resolution authorizing the transfer of real property to the City of Columbus for the maintenance of right-of-way along Fisher Road, County Road No. 22, Franklin County, Ohio (Board of Commissioners).

HUMAN RESOURCES

Laura Repasky, Director, Human Resources, and Damika Withers, Director, Office of Diversity, Equity, and Inclusion, offered a resolution approving a contract agreement with Raising the Bar Performance Group for racial equity and related training and management consulting and coaching services (\$469,705.00) (Human Resources).

Ms. Repasky and Ms. Withers reviewed information found in documents submitted with the proposed resolution.

Jessica McCurdy, Employee Wellness Administrator, Human Resources, offered a resolution authorizing a contract with Columbus Running Company, LLC (CRC) for event management services for the Franklin County Cooperative Health Improvement Program (Cooperative) (\$43,800.00) (Human Resources).

Ms. McCurdy reviewed information found in documents submitted with the proposed resolution.

PURCHASING

Megan Perry-Balonier, Director, Purchasing, and Damika Withers, Director, Office of Diversity, Equity, and Inclusion, offered a resolution approving purchases for various Franklin County agencies (\$7,052,405.65) (Purchasing).

Ms. Perry-Balonier and Ms. Withers reviewed information found in documents submitted with the proposed resolution.

Commissioner Boyce asked Ms. Withers if she created an annual report on purchasing data with minority small businesses. Ms. Withers noted that they keep the data weekly and could provide that information. Commissioner Boyce noted that it would be beneficial to publish an annual report, and with the State of the County coming up soon, he would like to highlight the performance in terms of inclusion. Commissioner Boyce thanked Ms. Withers for a job well done and noted that the county is leading the way in Ohio and being transparent, but that it is important to let the public know what the county is doing. Commissioner Boyce requested that Ms. Withers work with the Administration to add to the agenda a presentation for the State of the County; Ms. Withers agreed.

BOARD OF COMMISSIONERS

Kris Long, Deputy County Administrator, Board of Commissioners, offered a resolution adopting the Disposal of County Owned Personal Property Policy (Board of Commissioners).

Ms. Long reviewed information found in documents submitted with the proposed resolution.

Juan Torres, Chief Information Officer, Board of Commissioners, noted that this process took over a year, and the O.R.C. provides some flexibility. Franklin County has salvaged equipment for years, which will help streamline the process for agencies and ensure it is environmentally friendly.

Adam Frumkin, Chief Information Officer, Data Center, advised they had reviewed the digital equity coalition to look at equipment deemed unsuitable for public use in Franklin County but could be refurbished for residents to use in programs.

Jeanine Hummer, First Assistant Prosecuting Attorney and Chief Counsel, Prosecutor's Office, praised John Zervas for working months on this draft policy and explained how it will allow the commissioners to utilize it as a guideline and give them a map of the disposal process.
