Briefing Minutes May 10, 2018

The purpose of the meeting was to review resolutions submitted for the May 15, 2018 General Session, and to discuss other matters pertaining to the programs of the agencies. These notes are a synopsis of the meeting.

Commissioner O'Grady convened the meeting at 9:00 A.M.

PUBLIC DEFENDER

Christine Clarizio, Controller, Public Defender's Office, offered a resolution authorizing a one-year contract Between the City of Columbus, the Franklin County Board of Commissioners, and the Franklin County Public Defender Commission (\$1,252,381.00).

Ms. Clarizio reviewed information found in documents submitted with this proposed resolution.

SHERIFF

Dave Masterson, Director of Administrative Services, Sheriff's Office, offered a resolution authorizing a contract renewal with Relias Learning, LLC for online training services for the Franklin County Sheriff's Office Corrections and Law Enforcement personnel (\$49,900.00).

Commissioner Brown: What happens after the fostering time? Are they still in our custody while being fostered?

Mr. Winstel: Ideally, they are adopted by the foster's home through the Dog Shelter. They belong to the Shelter, but lives with the foster. We facilitate the connection between the foster and the adoption.

Erik Janas, Deputy Administrator: As we discussed, Commissioner, we are interested in seeing how we can do a fostering program in a pilot phase. There are some significant issues we need to sort out, mainly the liability issue associated with them still being our dogs. This is part of the continuing gathering of information to implement such a program.

JOB AND FAMILY SERVICES

Joy Bivens, Director, Job and Family Services, offered a resolution authorizing the Franklin County Job and Family Services Director to execute agreements and any other necessary documents for inter-county release and acceptance of funds with Allen County Department of Job and Family Services, Butler County Department of Job and Family Services, and Summit County Department of Job and Family Services.

Ms. Bivens reviewed information found in documents submitted with this proposed resolution.

Zak Talarek, Director, Office of Management and Budget asked the Commissioners to add a resolution to the May 15th agenda for a supplemental appropriations for Job and Family Services Summer Youth Works program. The Commissioners granted the request.
