Commissioner Boyce asked the Prosecutor's Office to review this resolution for conflicts.

Kris J. Long, Deputy County Administrator: Commissioners, as you know, the airport is building a \$2 billion terminal. We wanted to raise whether this Board would like to direct staff to draft a letter to the Columbus Regional Airport Authority (CRAA) Board regarding the success the Commissioners have had with MOUs with the building trades, as well as your significant goals for small and emerging business participation and labor force participation.

Commissioner O'Grady: I would like to have a letter drafted that highlights our interest in pursuing either a PLA or MOU with organized labor, as well as our interest in pursuing Diversity, Equity, and Inclusion policies in the construction.

Commissioner Boyce: Not only have we had great success with PLAs, such as with the building of the jail, but it is a resource that strengthens our community outside of the projects that we are working on. When we do things like building a new terminal at the airport, which is a \$2 billion effort, there is value to the broader community. These projects offer opportunities for people to have access to good-paying jobs, benefits, and resources to support them in sustaining themselves and their families. I am enthusiastic about this. It should be noted that the airport has a board of its own, and it is ultimately an independent organization. The County and City appoint to that board, but we do not control what they do. This is an effort to say to the CRAA Board that we, as a Board of Commissioners, believe that a PLA, MOU, or another type of agreement is a valuable asset to everyone in Central Ohio. I am very comfortable and confident that this is the right thing to do, and memorializing it in a letter is important.

Commissioner Crawley: As Commissioner Boyce said, the airport has its own board, and we will respect whatever the board decides to do. I want to add that this Board of Commissioners is one of the most pro-labor Board of Commissioners that the County has had. We continue to be a friend to labor because it makes a difference for our neighbors. It allows our neighbors to go from underemployed or unemployed straight into the middle class, which is good for our community. I would be remiss not to say that labor has not always been a friend to our community in general, especially to women in trades or veterans in trades. When I was in the legislature, I tried to get things moved to bring more people who were transitioning from the military to Ohio into labor. When we think about inclusivity, it is not just that we want people to get into the middle class. We absolutely want that to ensure people can care for themselves and their families, but we also want to ensure that there is always an equity lens. We always want to support women, women of color, minorities, and our veterans.

Commissioner O'Grady: We had to force that marriage to happen when it came to Building Futures. That was not the easiest match to make, but it is a great marriage now. I would also like to add that no one should be shocked by our interest in this and our desire to get a letter out. This is just us formalizing our interest and our wishes in writing.

Commissioner O'Grady (cont.): We have all had a track record of being pro-labor for a long time. We have a record of doing these types of projects and doing them well. I think putting this in writing is important.

Ms. Long: We will have staff draft a letter for your review and signature.

RESOLUTION TO BE PASSED AT BRIEFING SESSION
