## **ENGINEER**

William "Fritz" Crosier, Chief Deputy Engineer, Engineer's Office, offered a resolution for plan approval of the improvement of Alum Creek Drive at Rohr Road, Hamilton Township and Madison Township, Franklin County, Ohio (Engineer).

Vivian Turner and Bart Logan offered a resolution authorizing the Franklin County Department of Job and Family Services Director to enter into a Memorandum of Understanding with the City of Columbus Department of Neighborhoods to support the My Brother's Keeper Village initiatives and services (Job and Family Services).

Commissioner Boyce: Why is there no budget amount attached to this item?

Ms. Turner: It is actually \$100,000, in total.

Commissioner Boyce: Is the budget itemized within the resolution?

Ms. Turner: No, but we will make sure that the resolution is updated before General Session.

Kenneth N. Wilson, County Administrator: Can you update the resolution and the resolution summary?

Mr. Logan: Yes, we will update both of them.

Vivian Turner and Bart Logan offered a resolution approving a subaward agreement with Dress for Success Columbus for a youth leadership program (\$70,000.00) (Job and Family Services).

Ms. Reardon: Correct. And, the scope of work is the same.
