#### FRANKLIN COUNTY BOARD OF COMMISSIONERS

Briefing Session Minutes Thursday, February 16, 2023

The purpose of the meeting was to review resolutions submitted for the February 21, 2023, General Session, and to discuss other matters pertaining to the programs of the agencies.

### **AUDITOR**

Trenton Weaver, Staff Counsel, Auditor, offered a resolution authorizing a Master Service Agreement with Jotform, Inc. for the procurement of an online form builder and form creator (\$9,618.00) (Auditor).

#### **CORONER**

Amanda Alvarez Wright, Director of Operations, Coroner's Office, offered a resolution authorizing two agreements with the Drug Enforcement Agency to participate in sharing information for input into the National Forensic Laboratory Information System (NFLIS) and to authorize the County Administrator to sign on behalf of the Coroner (Coroner).

Commissioner Boyce: Is that data provided in aggregate form?

Ms. Alvarez Wright: It will be provided to them on a monthly basis from our case management system, which will occur automatically.

Commissioner Boyce: We are not giving out individual information, correct? We are just giving overall numbers?

Ms. Alvarez Wright: Correct. We are giving case information for specific drugs, but no information regarding specific people. However, if coroner's reports are requested later, that is public information that they are able to request. This resolution deals strictly with toxicology data points.

Commissioner Boyce: What is left in the fund? After we do this resolution, do we have resources for the rest of the year? Is there another round? You said fifty-five agencies applied, and nine are being awarded, so is there another opportunity to take a bite of the apple for them?

Mr. Brown: We are not planning to have another Health Equity round for this year. We usually do Health Equity once a year. However, we do have two other grant opportunities for organizations. One is our general Community Partnerships Grant. That application is tentatively scheduled to open in the spring. Before that, we will also have a Capital Grant process, where organizations will have the chance to apply for capital funding. If there is a Health Equity program for which organizations would like to apply for funding, they will have the opportunity under our general Community Partnerships Grant.

Commissioner O'Grady: Is the Capital Grant the one that just opened on February 1<sup>st</sup>?

Mr. Brown: No, the Capital Grant is slated to open within the next couple of weeks.
