Commissioner Crawley: This resolution has an appropriation for Legal Aid Society for a little more than \$40,000.00, and the first resolution that you presented also has an

appropriation for Legal Aid Society. If you could, please talk about the different services that would be provided between those two contracts?

Ms. Funk: Thank you, Commissioner. I am going to ask Nancy Male, our Grants Administrator, to give a little bit of background for these two different programs that are offered through Legal Aid Society.

Nancy Male, Grants Administartor, Office on Aging: Good morning, Commissioners. For the first resolution, which looks at community stabilization, under that grant, Legal Aid Society will help seniors who may be facing housing issues to keep them stabilized in their neighborhoods. The second resolution, will allow for outreach to seniors who are homebound, but may need legal assistance in civil cases. For example, this could be involving issues with land owners, Social Security, or the need for wills.

Amy Funk offered a resolution authorizing seven grant agreements to provide supportive services for Franklin County Senior Options (\$772,688.00) (Office on Aging).

Ms. Funk reviewed information found in documents submitted with the proposed resolution.

Amy Funk offered a resolution authorizing the acceptance of a donation from Zangmeister Cancer Center/American Oncology Partners to the Franklin County Office on Aging (\$10,000.00) (Office on Aging).

ECONOMIC DEVELOPMENT AND PLANNING

Emanuel Torres, Assistant Director, Economic Development and Planning, offered a resolution authorizing a COVID-19 Recovery Grant with Columbus State Community College – Ohio Small Business Development Center for the provision of program administration services for the COVID-19 Small Business Response and Recovery Program (\$500,000.00) (Economic Development and Planning).

Mr. Torres reviewed information found in documents submitted with the proposed resolution.

Emanuel Torres offered a resolution authorizing a COVID-19 Recovery Grant with The Wells Foundation for the COVID-19 Small Business Response and Recovery Program (\$4,500,000.00) (Economic Development and Planning).

Commissioner Crawley: For the first resolution, is it possible for a small business to apply for the grant if they fit into two categories, one of which has at least one W2 employee and another that they are looking to rehire? Is it possible for them to apply for two grants, or do they have to decide on which grant to apply for in the process? Can there be any overlap?

Mr. Torres: The answer is yes. A small business that has at least one W2 employee would qualify for that \$10,000.00, and if they are looking to rehire, that could qualify the business for an additional \$10,000.00, possibly receiving up to \$20,000.00.

Kenneth N. Wilson, County Administrator: Is the fiscal manager fee in both these resolutions roughly just under ten percent? I looked at the second resolution's management fee. Is that number consistent with the Columbus State agreement? I want to make sure I have an understanding on that administrative fee, as a part of both the agreements.

Mr. Torres: Yes, we have provisions within the agreements. For the Wells Foundation, there is up to ten percent of the grant funds. I believe they have established a set fee that is below that ten percent mark. On the SBDC, given that they are effectively administrating the program overall, and we had to make some decisions on the fiscal side, and what expsenses needed to be paid. Some of the funding that will be covered from the county funding, would be tied to those otherwise administrative items, but the City of Columbus funds would be covering funds needed right away because they received their funding sooner than the county. However, at the end of the day, the amounts coming from the city and the county would be equal.

James Schimmer, Director, Economic Development and Planning: Commissioners, it really relates to a timing issue. It is about trying to get the city in one place and us in another place. We are happy to go into more detail, if needed.
