AUDITOR

Trenton Weaver, Staff Counsel, Auditor, offered a resolution authorizing a consultant contract with Amplifire Strategic Communications for critical communications services related to the 2023 Property Reappraisal (\$50,000.00) (Auditor).

ENGINEER

OFFICE OF DIVERSITY EQUITY & INCLUSION

Damika Withers, Chief Economic Equity and Inclusion Officer, Office of Diversity Equity and Inclusion, offered a resolution authorizing the County Administrator to execute an agreement with Columbus Fashion Alliance to support programs and services that will support economic growth and support underrepresentation in the fashion industry (\$500,000.00) (Office of Diversity Equity & Inclusion).

Ms. Withers reviewed information found in documents submitted with the proposed resolution.

Commissioner Boyce: Are we the main sponsor for the Columbus Fashion Alliance?

Ms. Withers: I know that last year the City of Columbus partnered with us, but I believe that this year we are the sole grantee. I will confirm that.

Commissioner Boyce: This is the kind of innovative investment that is not traditional for the County to make. While I think it is worthwhile, I want to make sure that folks know that the County is investing in this effort. These are the public's funds, and it should be noted that the County is pushing for this and investing in it.

Ms. Withers: We have included the information regarding what we did last year with the Fashion Alliance in the State of the County report. We will continue to promote their efforts moving forward and continue to encourage that collaboration.

Commissioner Boyce: I was thinking more from the Fashion Alliance's side. It is not about the Board of Commissioners getting credit, but I want to make sure that people understand what Franklin County does and how we invest their funds.

Joy Bivens, Deputy County Administrator, Board of Commissioners: As they are promoting, I know that there are a lot of things that go out, such as packages. They also have commercials and mini-video segments that they put out.

Ms. Bivens (cont.): I think that it would be helpful to have a conversation with them and ensure that our branding is noticeable and consistent. We want to acknowledge that the County is not just a partner, but a strong partner.

Ms. Withers: We will work with Columbus Fashion Alliance to ensure that branding is there moving forward.

Commissioner Crawley: Yes, our branding is important, but it is not just that. The individuals that end up coming through the Alliance end up being entrepreneurs and small business owners. They are selling locally, and those resources and that revenue come right back into our economy. I think even the people who are coming through the Alliance and benefit from our investment have to understand that these are public funds that are helping them launch their careers and businesses, but there is a return on investment for the community. We want others to follow through that pipeline, as well.

Kenneth N. Wilson, County Administrator: They are building brands, and they are bringing a level of inclusiveness to the fashion industry that wasn't really there before in Franklin County. A key part of this partnership is the Future of Fashion internship program, and that is one of the aspects that Commissioner Crawley is referring to that is creating that exposure for the individuals.

ECONOMIC DEVELOPMENT AND PLANNING

Emanuel Torres, Assistant Director, Economic Development and Planning, offered a resolution authorizing the Assignment and Assumption Agreement of the Amended and Restated Community Reinvestment Area Agreement between Franklin County, DRCS Rail-Site 8, LLC and Columbus Rickenbacker Industrial, LLC (Economic Development and Planning).
