Briefing Minutes February 16, 2017

President O'Grady Commissioner Boyce

AUDITOR

Zak Talarek, Director of Office of Management and Budget, offered a resolution amending the Procurement Card Program Policies and Procedures.

President O'Grady: When I mention all the services that we provide, when I am out speaking, jaws tend to drop when I mention that we have transportation services that will pick them up.

Ms. Carroll: Transportation is always the number one service people are interested in.

President O'Grady: There are a multitude of services that transportation provides.

Ms. Carroll: Transportation services support the caregivers as well. It gives them a break and does not require them to take off work to drive a loved one to appointments.

Commissioner Boyce: What do the letters from the State Auditor mean?

Ms. Carroll: Every time we bring a contract before the Commissioners, we have to investigate the company to see if they are in good standing.

Mr. Talarek: It is a state requirement that the agency does the search. We have an obligation to search.

Commissioner Boyce: Thanks. What are the names on the search list?

Mr. Talarek: Those are near matches of the company you searched for.

Ken Wilson, County Administrator: We must do the search. Over the years, the State Auditor has audited us to make sure we have done these searches.

Commissioner Boyce: If the company's name did show up on the list, is this an automatic disqualification?

Ms. Carroll: No, but we have to dig into the matter to make sure the issue has been resolved.
