FRANKLIN COUNTY COMMISSIONERS

Briefing Minutes June 8, 2017

Commissioner Brown

The purpose of the meeting was to review resolutions submitted for the June 13, 2017 General Session, and to discuss other matters pertaining to the programs of the agencies. These notes are a synopsis of the meeting.

Commissioner Brown convened the meeting at 9:00 A.M.

CLERK OF COURTS

Jason Sankey, CIO, Clerk of Courts, and Adam Luckhaupt, CIO, Board of Commissioners, offered a resolution authorizing a non-general fund supplemental appropriation to support data migration readiness for the Franklin County Justice System Modernization Project.

Mr. Sankey reviewed information found in documents submitted with this proposed resolution.

DOMESTIC RELATIONS

Ms. Jones: We do. We often see the same young people go through our system. For 2016, we had thirteen youth to test and get their GED while in our facility. We have seen an upwards of 90% reduction in fights and altercation during the summer school classes. We are going to begin to have weekly meetings on Fridays to see what teaching curriculum and activities that our summer school teachers have, that our regular school teachers are not utilizing that help them stay more engaged in the summer.

Commissioner Brown: It would be great if you could send each Commissioner office that data.

Ms. Jones: Will do.

Commissioner Brown: It would be helpful if you could explain how your agency and Homeland Security and Justice Programs work together on similar issues.

Mr. Young: I can do that. It is easy to get confused. Some cross collaboration occurs.
