## MINUTES OF GENERAL SESSION

August 12, 2021

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room, at 9:00 A.M. on Thursday, August 12, 2021.

President Boyce called the meeting to order at 9:08 A.M.
