## MINUTES OF GENERAL SESSION

October 15, 2024

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room at 9:00 A.M. on Tuesday, October 15, 2024.

Commissioner Boyce called the meeting to order at 9:35 A.M.

Commissioner Boyce: October is recognized as National Domestic Violence Awareness Month. Unfortunately, each year, millions of Americans are affected by domestic violence. Here in Franklin County, residents contribute a small fee when they marry, divorce, or annul a marriage. We are proud to allocate the funds collected from those fees to CHOICES for Victims of Domestic Violence, one of Ohio's oldest and largest domestic violence shelters.

Today, we are honored to have Dr. Maria Houston Beck, the Executive Director from CHOICES here to accept these funds and share more about the critical services they provide. I would like to invite Maria to speak, and afterward, turn it over to our OMB Director, Zak Talarek, to present the resolution.

Dr. Maria Houston Beck, Executive Director, CHOICES, thanked the commissioners for their ongoing support and recognition of the importance of domestic violence awareness, highlighting the critical services provided through partnership with CHOICES.

Commissioner O'Grady thanked Dr. Beck for the work CHOICES is doing in Franklin County.

Commissioner Boyce thanked Dr. Beck for the work CHOICES is doing in Franklin County, sharing a personal story about his father to demonstrate the need to confront domestic violence issues and undergird the victims and their families.

Joy Bivens, Deputy County Administrator, thanked Dr. Beck for the work CHOICES is doing in Franklin County and invited her to attend the Men's Empowerment Soul Talk on November 23, 2024.

Commissioner Boyce: Before we proceed, I'd like to remind anyone who is experiencing domestic violence, or if you know someone who is, that CHOICES provides a 24-hour crisis hotline at 614-224-HOME.
