MINUTES OF GENERAL SESSION

March 2, 2023

The Franklin County Board of Commissioners convened in the Commissioners Briefing Room, at 9:00 A.M. on Thursday, March 2, 2023.

Resolution No. 0152-23, authorizing grant agreements with Asian American Community Services, Blendon Township, Catholic Social Services, Central Community House, Clintonville-Beechwold Community Resources Center, Community Refugee and Immigration Services, Concord Counseling Services, Gladden Community House, Greater Hilltop Area Shalom Zone CDC, St. Stephen's Community House, Syntero Inc., The Ohio State University College of Social Work, and Village Connections to provide services and programming that will promote and enhance the social and community context aspect for seniors in Franklin County (\$1,171,961.00) (Office on Aging).

Resolution No. 0153-23, authorizing grant agreements with Alzheimer's Association of Central Ohio, Catholic Diocese of Columbus J.O.I.N., Charitable Pharmacy of Central Ohio, City of Columbus dba Central Ohio Area Agency on Aging, the City of Columbus Recreation and Parks Department, the City of Groveport, Columbus Speech and Hearing Center, Legal Aid Society of Columbus, LifeCare Alliance, Mid-Ohio Foodbank and The Breathing Association to provide

services and programming that will promote and enhance healthcare access and quality for seniors in Franklin County (\$1,426,025.00) (Office on Aging).
