## MINUTES OF GENERAL SESSION

March 1, 2022

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room, at 9:00 A.M. on Tuesday, March 1, 2022.

Commissioner Crawley called the meeting to order at 9:12 A.M.

Commissioner Crawley: My colleagues and I want to take a moment to acknowledge the retirement of one of our Franklin County family members: Director of Human Resources, Rob Young. We are fortunate to have had a professional like Rob to navigate the significant challenges and transitions human resources has faced over the past ten years; from recruiting and maintaining a talented workforce, to recognizing the benefits of wellness initiatives in keeping staff safe and productive. Rob has been a valuable director to help the county become a recognized leader in the community. His forward thinking and "can do" approach have been paramount on our path forward supporting every resident, every day, and will reflect favorably on the future of Franklin County. We wish you well in all your endeavors and thank you for a lifetime of public service and dedication to others. We would like to present you with this ceremonial resolution as a token of our gratitude and appreciation. Next, I would like to turn it over to my colleagues to say a few words.

Robert Young, Director, Human Resources, shared brief remarks.

Craig Moncrief, Attorney, Plank Law Firm, LPA: Grove City recently approved a Community Reinvestment Area (CRA) expansion for this area, so this annexation is part of that. Currently, no development plan has been proposed yet, but it is likely going to be for a mixed-use development.
