MINUTES OF GENERAL SESSION

March 15, 2022

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room, at 9:00 A.M. on Tuesday, March 15, 2022.

Commissioner O'Grady called the meeting to order at 9:06 A.M.

Commissioner O'Grady: Good morning. Today, we continue with our recognition of Women's History Month. On average, women make 80 cents of every dollar a man makes. Women still do not have Equal Rights ratified in the Constitution, which has failed decade after decade. That is why organizations like the Panhellenic Council are so important. The sororities help young women by focusing on professional leadership and empowering women. I would like to welcome Lisha West, President of Alpha Kappa Alpha. Commissioner Boyce moved to approve Resolution 0201-22, seconded by Commissioner O'Grady. The Resolution was adopted by roll call vote.

Resolution No. 0202-22, authorizing a final contract modification with The Righter Company, to close out the Century Acres Pump Station and Force Main Project for a decrease of \$23,770.29. (\$1,653,541.94) (Sanitary Engineers), presented by Stephen Renner, Director, Sanitary Engineers.
