MINUTES OF GENERAL SESSION

March 22, 2022

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room, at 9:00 A.M. on Tuesday, March 22, 2022.

Commissioner Crawley called the meeting to order at 9:11 A.M.

Commissioner Crawley: In continuation of recognizing Women's History Month, we wanted to take the time today to acknowledge Equal Pay Day, which is Thursday, March 24. Equal Pay Day is the symbolic day dedicated to raising awareness of the gender pay gap. In the United States, this date symbolizes how far into the year the average woman must work (in addition to her earnings last year) to have earned what the average man had earned the entire previous year. The Women's Fund of Central Ohio is very focused on this issue, knowing that pay is a building block in determining one's future. Here to speak more about this very important issue is Kelly Griesmer, President of the Women's Fund of Central Ohio.
