Briefing Minutes May 31, 2018

The purpose of the meeting was to review resolutions submitted for the May 29, 2018 General Session, to discuss other matters pertaining to the programs of the agencies and to vote on a resolution to go into Executive Session. These notes are a synopsis of the meeting.

DOMESTIC RELATIONS

Barbara Reeves, Deputy Director of Business, Domestic Relations Court, offered a resolution authorizing a settlement to Scott Adams for a disputed vehicle damage claim due to an auto accident involving The Franklin County Common Pleas Domestic Division (\$1,233.59).

AUDITOR
