## MINUTES OF GENERAL SESSION

May 7, 2024

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room, at 9:00 A.M. on Tuesday, May 7, 2024.

Commissioner Boyce called the meeting to order at 9:04 A.M.

Approval of the minutes for the February 1, 2024, Briefing Session; and the February 6, 2024, General Session. Commissioner O'Grady moved to approve the minutes, seconded by Commissioner Boyce. The minutes were approved by roll call vote.

Commissioner Boyce made brief remarks welcoming the sisters of Delta Sigma Theta Sorority.

Joy Bivens, Deputy County Administrator, commented that the African American Wellness Agency and 100 Black Men of Central Ohio will assist with the Men's Empowerment Summit.

Commissioner Boyce commented on how Franklin County has been leading this initiative to respond to the challenges facing black men, including mental health, and the broader impact those challenges have on the community.

Kenny R. Hampton, President, African American Male Wellness Agency, commented on the opportunity to partner with Franklin County and the agency's commitment to supporting the entire community.

Commissioner O'Grady commented on how partnering with organizations like 100 Black Men of Central Ohio and the African American Wellness Agency is really making a difference for a community in need.

Commissioner O'Grady moved to approve Resolution 0387-24, seconded by Commissioner Boyce. The Resolution was adopted by roll call vote.

**Resolution No. 0388-24,** authorizing a subgrant award with Shelter in Place for community-based services for individuals diverted from the prison system and/or at high risk for future criminal justice involvement under the FY 2024 Targeted Community Alternatives to Prison (TCAP) grant program (\$100,000.00) (Justice Policy and Programs), presented by Caitlin Looney, Deputy Director, Justice Services, Justice Policy and Programs.

Ms. Looney reviewed information found in documents submitted with the proposed resolution.

Commissioner O'Grady moved to approve Resolution 0388-24, seconded by Commissioner Boyce. The Resolution was adopted by roll call vote.

**Resolution No. 0389-24,** authorizing a Third Modification to the contract with Amick Consulting Group, LLC for funding acquisition services (\$430,130.55) (Sanitary Engineers), presented by Stephen Renner, Director, Sanitary Engineering.
