## MINUTES OF GENERAL SESSION

June 18, 2024

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room, at 9:00 A.M. on Tuesday, June 18, 2024.

Commissioner Boyce called the meeting to order at 9:13 A.M.

Commissioner Boyce: Refugee Week is a global celebration annually from June 17, through June 23, to honor the resilience and strength of refugees worldwide who have been forced to flee their homes due to conflict or persecution. Here in Franklin County, we want to continue honoring the contributions, creativity, and tenacity of refugees and people seeking sanctuary. As Franklin County's demographics continue to change, we recognize that immigrants and refugees are an integral part of our present, our future, and our workforce. Here with us today is Nadia Kasvin, Executive Director & Co-Founder of US Together. Welcome, Nadia.

Ms. Kasvin spoke about World Refugee Day. Ms. Kasvin noted that the United Nations designates this day to honor refugees around the globe. It falls on June 20 each year and celebrates the strength and courage of people who have been forced to flee their home country to escape conflict or persecution.

Commissioner Crawley offered thanks and support for US Together and the vital work for refugees worldwide and in Franklin County.

Commissioner Boyce offered remarks on Juneteenth, a celebration that takes place each year on June 19, 2024. Juneteenth dates back to 1865 and commemorates when enslaved peoples in Texas were declared free.

Commissioner Crawley commented on Juneteenth, celebrating perseverance in the face of adversity and not repeating past mistakes.

Commissioner Crawley commented on digital equity, programming, and working in partnership and asked the County Administration how collaborations with other entities, such as the City of Columbus, can be expanded and services offered to more people who might be waiting.

Kenneth N. Wilson, County Administrator, stated that the two projects operate independently of the digital equity investment and that efforts can be made to expand upon what is planned.
