MINUTES OF GENERAL SESSION

July 9, 2024

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room at 9:00 A.M. on Tuesday, July 9, 2024.

Commissioner Boyce called the meeting to order at 9:09 A.M.

Approval of the minutes for the February 15, February 22, and March 7, 2024, Briefing Sessions; the February 27, 2024, General Session; and the May 29, 2024, Administrative Briefing. Commissioner Crawley moved to approve the minutes, seconded by Commissioner O'Grady. The minutes were unanimously approved by roll call vote.

Resolution No. 0560-24, authorizing Chuck's Septic Tank Sewer and Drain, Inc. (CST) to provide services as necessary for an immediate repair to the 970 Dublin Road Sanitary Sewer Line, Franklin County, Ohio, declaring an emergency due to unforeseen issues (\$52,822.00) (Engineer), presented by William "Fritz" Crosier, Chief Deputy of Engineering, Engineer's Office.

Mr. Crosier reviewed information found in documents submitted with the proposed resolution.

Commissioner O'Grady moved to approve Resolution 0560-24, seconded by Commissioner Crawley. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0561-24, authorizing a Memorandum of Understanding with Appriss Insights, LLC to integrate booking data provided by the Franklin County Sheriff's Office into TheSheriffApp.com (Sheriff), presented by Albert J. Smith III, Assistant Finance Director, Sheriff's Office.

Mr. Smith reviewed information found in documents submitted with the proposed resolution.

Commissioner O'Grady moved to approve Resolution 0561-24, seconded by Commissioner Crawley. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0562-24, authorizing a contract with GoView LLC for the purchase of Mobile Surveillance Camera Trailers (\$96,900.00) (Emergency Management Agency), presented by Jeff Young, Director, Emergency Management Agency.

Commissioner O'Grady moved to approve Resolution 0548-24, seconded by Commissioner Crawley. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0563-24, authorizing Community Partnership 2024 Grant Agreement with 22 nonprofit community agencies (\$3,740,145.00) (Community Partnerships), presented by Curtis Brown, Administrator, Community Partnerships. Mr. Brown reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley noted how she loves this time of year when they approve the community partnership grants and how difficult it is to award due to the number of applicants. She encourages residents to come to the meetings, see what is being awarded, and learn about the organizations and what they are doing. Commissioner Crawley called out the agencies awarded grants that focus on ending violence, and how they continue to do their part.

Commissioner Boyce discussed the Charity Newsies and how, during his youth, they would hand out clothes. Commissioner Boyce also noted that it is the little things that can make a big difference, and when these agencies are funded, it is the best part of the job.

Commissioner O'Grady expressed his appreciation for Community Partnerships' work and noted that all agencies do tremendous work. When they rise-up the agencies awarded the grants, they are the best of the best.

Commissioner O'Grady moved to approve Resolution 0563-24, seconded by Commissioner Crawley. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0564-24, authorizing a grant agreement with the National African American Male Wellness Agency to support the African American Wellness Educational initiatives and events (\$450,000.00) (Office of Diversity Equity & Inclusion), presented by Damika Withers, Director, Office of Diversity Equity & Inclusion, Perry Gregory, Senior Vice-President, and John Gregory, Founder, CEO of National Center for Urban Solutions.

Ms. Withers and Mr. Gregory reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley discussed her experiences, the importance of mental health, and the fact that it is Minority Mental Health Month and thanked Mr. Gregory for helping the community.

Commissioner O'Grady thanked Mr. Gregory and noted that it is easy to do this work with great people like him.

Commissioner Boyce noted his past health struggles, thanked his colleagues for their advocacy, and believes the needle is moving in the right direction for African American Wellness.

Kenneth Wilson, County Administrator, commented on the importance of the work being done and the need to care for male and female African American residents, and thanked the commissioners for their work and support of wellness initiatives.
