July 23, 2024

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room at 9:00 A.M. on Tuesday, July 23, 2024.

Commissioner Boyce called the meeting to order at 9:20 A.M.

Commissioner Boyce: Before starting our agenda, we have some special guests with us this morning.

Commissioner Boyce (cont.): Celebrated every July is Disability Pride Month, which raises awareness while honoring the history, achievements, experiences, uniqueness, and struggles of our disabled community. On July 26, we will celebrate the passing of the Americans with Disabilities Act (ADA), a landmark legislation that broke down barriers and charted the path for inclusion in our society. While discrimination persists for the 1 in 4 U.S. adults living with a disability here in Franklin County, we aim to promote visibility and serve as an example of inclusivity. Here to celebrate and uplift Disability Pride Month is one of our hometown heroes, Kevin Cantrell, two-time Special Olympics Powerlifting Gold Medalist, his mother, Debbie, Coach Andrew, and joining him is Ryan Phillips, Franklin County's Director of Special Olympics with the Board of Developmental Disabilities. Welcome, Mr. Cantrell, and Mr. Phillips.

Mr. Cantrell made brief remarks sharing his athletic journey in powerlifting.

Mr. Phillips commented on Mr. Cantrell's dedication and commitment to the sport.

Commissioner Boyce, Commissioner Crawley, and Commissioner O'Grady offered remarks on Mr. Cantrell's inspiring achievements and fortitude.

Commissioner Boyce: Thank you. We have a ceremonial resolution for you and would love to get some pictures in front of the dais.

Commissioner Boyce: Here to further celebrate diversity and inclusion are our good friends from The Heritage Tours Project, Toni Bell, and joining her are some of the students from their most recent Southern civil rights tour. Please join us at the podium to tell us more about the Heritage Project. We'd love for your students to highlight their experiences on the Civil Rights Tour and the impact that tour has had on their goals and outlook.

Toni Bell made remarks on the history of The Heritage Tours Project, which began in 2018, thanking the commissioners for their support.

Lincoln Stokes and Devin Francis-Belcher commented on their experience working with youth on The Heritage Tours Project. They introduced several individuals, including students, a parent, and a teacher, who remarked on their experiences on a recent trip.

Joy Bivens, Deputy County Administrator, commented on the value of the experience, especially its multi-generational nature.

Commissioner Crawley remarked on her experience attending a recent civil rights tour and the powerful impact of knowing the history, struggle, and perseverance of those who came before.

Commissioner O'Grady opined on Franklin County's motto, "Every Resident, Every Day," and how programs like The Heritage Tours project allow us to get to know one another better.

Commissioner Boyce commented on the value of diversity, equity, and inclusion as a fundamental investment that strengthens the foundation of Franklin County and its residents.

Mr. Edmonds highlighted that there will be one underwriting syndicate for the convention center and a separate one for the next proposed resolution on the agenda. Tom Ricchiuto, Financial Advisor, Baker Tilly, added that the present value is \$6.4 MM, in the 4-5% range.
