September 10, 2024

Commissioner Boyce called the meeting to order at 9:09 A.M.

Commissioner Boyce: Welcome to September; let's take a moment to reflect on National Child Support Awareness Month, which we observed in August. This reflection reminds us of the crucial role that child support plays in ensuring our children's well-being and future success.

Since its establishment in 1975, the child support program has undergone significant changes over the past 48 years, evolving from a focus on recovering public assistance costs to prioritizing families' needs. This is also a time to recognize the commitment of those who work tirelessly to advocate for and support our nation's children, making sure they receive the financial and emotional resources necessary to thrive.

Today, we have with us the Franklin County Child Support Enforcement Agency Director, Susan Brown, who will share more insights on National Child Support Awareness Month. Please join me in welcoming Director Brown.

Susan Brown, Director, Child Support Enforcement Agency: Thank you, Commissioner Boyce. Good morning, County Administration and Commissioners. My name is Susan Brown, and I am the director representing the staff of the Child Support Program. Thank you for taking the time today to recognize and raise awareness about the child support program. As you mentioned, the program was established in 1975, and we have changed since then. In honor of Child Support

Awareness Month in August, here are some facts about the program. It collected billions of dollars in child support. The child support program is a critical income source for families. Nationally, the program collected \$6 billion in child support payments and the 232 child support staff here in Franklin County collected \$145 million for families. This kind of support helps children and families thrive. Research has shown that consistent child support payments allow for parents and caretakers to be more involved in their children's lives and their children have better outcomes. Seventy-two percent of child support was collected by income withholding, providing a steady, consistent, dependable income. It is very efficient. The program operates with remarkable efficiency, collecting seven dollars for every dollar spent on the program. This makes it one of the most cost-effective government programs. It served one in five children nationally, and nationally, the child support program served 12.8 million children. That is one in five in the United States. Franklin County has served over 78,000 children and over 100,000 parents, making child support one of children's largest income support programs. We know that a realistic and balanced approach to child support is essential to supporting consistent child support payments, family relationships and child well-being.

Director Brown (cont.): Every parent has the responsibility to support their children financially, and much of our work revolves around supportive services to assist the parents in doing that. However, children need more than just financial support, and people may not be aware that child support offers services beyond the collection of child support. The roles that fathers play in their child's development and the fathers' meaningful involvement impact both the child's well-being and the fathers' well-being. We will highlight workforce services, safe access to child support services federal grant, the scope of our outreach program, and education and dissemination of information through social media and marketing. Another service worth mentioning is our Federal Access Visitation Mediation Program. The agency offers a mediation program where parents can enter an agreement customized for them. The parents can establish parenting time and an agreedupon child support order. This program does not have attorneys, court hearings, or filing fees for the residents. We have a number of child support staff in the audience, and I would like them to stand. I want to express my appreciation to all the staff here today and to the staff members who work tirelessly for families. They coordinate child support awareness events, including this year's Franklin County One Door Empowerment Day, which hosted over 200 residents at COSI. They also coordinate other staff recognition events, specific child support awareness events, and outreach programming. We also have our grant project managers here today. Thank you, again, for taking the time to recognize the program.

Commissioner Crawley asked Mayor Mattox what the population was in Valleyview and the underlying reason for breaking away from Franklin Township. Mayor Mattox noted the population was approximately 687 residents and felt that breaking away was fiscally best for the Village and Franklin Township.

Commissioner Crawley asked what county resources this new township would need. Mayor Mattox stated that they currently contact the City of Columbus for fire and emergency services.

Kenneth Wilson, County Administrator, asked if the village had a Memorandum of Understanding (MOU) with the City of Columbus and if existing agreements concerning water and sewer carry over or if new agreements will be executed. Mayor Mattox noted that the village had its own police department and would execute new agreements.
