January 17, 2023

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room, at 9:00 A.M. on Tuesday, January 17, 2023.

Commissioner O'Grady called the meeting to order at 9:15 A.M.

Resolution No. 0022-23, authorizing a two-year contract with Pediatric Academic Association, Inc. for medical services for the Franklin County Juvenile Intervention Center (\$1,929,723.00) (Domestic Relations), presented by Barb Reeves, Deputy Director, Court of Common Pleas, Domestic Relations Division.

Ms. Reeves reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0022-23, seconded by Commissioner Boyce. The Resolution was unanimously adopted by roll call vote.

Cornell Robertson, Engineer, Engineer's Office: Before I present our first resolution, I would like to mention something that we are very excited about at the Franklin County Engineer's Office. Mr. Robertson reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0023-23, seconded by Commissioner Boyce. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0024-23, authorizing the Franklin County Engineer to enter into a contract modification with Terracon Consultants, Inc., for construction inspection services for the Fisher Road project, Franklin Township, Franklin County, Ohio, for an increase of \$46,225.00, for a revised contract amount of \$198,889.00 (\$198,889.00) (Engineer), presented by Cornell Robertson, Engineer, Engineer's Office.

Mr. Robertson reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0024-23, seconded by Commissioner Boyce. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0025-23, authorizing Franklin County agencies to participate in the Ohio Department of Transportation Cooperative Purchasing Program (Engineer), presented by Nick Soulas, Government Affairs Liaison, Engineer's Office.

Mr. Soulas reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0025-23, seconded by Commissioner Boyce. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0026-23, declaring personal property obsolete and no longer needed for Franklin County use, and authorizing sale and/or destruction of said personal property (Engineer), presented by Nick Soulas, Government Affairs Liaison, Engineer's Office.

Mr. Soulas reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0026-23, seconded by Commissioner Boyce. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0027-23, authorizing the County Administrator and the County Prosecutor to amend the contracts with the forensic pathologists who are no longer employed by the Franklin County Coroner for professional services (Prosecuting Attorney), presented by Jeanine Hummer, First Assistant Prosecuting Attorney and Chief Counsel, Prosecuting Attorney's Office.

Ms. Hummer reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0027-23, seconded by Commissioner Boyce. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0028-23, authorizing a one-year agreement with Criterion Pictures USA, Inc. for the nonexclusive rights to provide viewing access of motion picture DVDs for inmates in the Franklin County Correctional Center (\$2,370.00) (Sheriff), presented by Albert J. Smith III, Assistant Finance Director, Sheriff's Office.

Mr. Smith reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0028-23, seconded by Commissioner Boyce. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0029-23, authorizing the County Administrator to sign a letter of agreement to allow the Franklin County Sheriff's Office to provide physical space for use by the Franklin County Coroner's Office as an alternate morgue location (Sheriff), presented by Albert J. Smith III, Assistant Finance Director, Sheriff's Office.

Mr. Smith reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0029-23, seconded by Commissioner Boyce. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0030-23, authorizing the execution of the Pre-Award Conditions and future acceptance of a 2022 American Rescue Plan Grant to augment the Central Ohio Violence Eradication Response Team (\$2,096,327.35) (Sheriff), presented by Albert J. Smith III, Assistant Finance Director, Sheriff's Office.

Mr. Smith reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0030-23, seconded by Commissioner Boyce. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0031-23, appointing four members to the Villages at Galloway New Community Authority's board; and fixing the surety for those trustee's bonds (Economic Development and Planning), presented by James Schimmer, Director, Economic Development and Planning.

Mr. Schimmer reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0031-23, seconded by Commissioner Boyce. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0032-23, approving a COVID-19 Recovery Grant with Besa Community, Inc. for volunteer event coordination to support distressed Franklin County neighborhoods (\$250,000.00) (Job and Family Services), presented by Vivian Turner, Chief Administrator, Job and Family Services.

Ms. Turner reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0032-23, seconded by Commissioner Boyce. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0033-23, approving a contract agreement with the United Way of Central Ohio, Inc. for tax preparation services (\$75,000.00) (Job and Family Services), presented by Vivian Turner, Chief Administrator, Job and Family Services.

Ms. Turner reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley: When I was attending law school at Capital University, I used to volunteer with the Volunteer Income Tax Assistance (VITA) program. I absolutely love that program and the assistance it provides, especially to our seniors, not just low and moderate-income individuals. Seniors sometimes get taken advantage of when they try to go to other tax preparers. I really support this program, and I am glad we continue to support it here.

Resolution No. 0035-23, approving purchases for various Franklin County agencies (\$41,826,905.65) (Purchasing), presented by Megan Perry-Balonier, Director, Purchasing.

Ms. Perry-Balonier reviewed information found in documents submitted with the proposed resolution.

Commissioner Boyce moved to approve Resolution 0035-23, seconded by Commissioner Crawley. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0036-23, approving purchases for various Franklin County agencies (\$4,250.00) (Purchasing), presented by Megan Perry-Balonier, Director, Purchasing.

Ms. Perry-Balonier reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0036-23, seconded by Commissioner O'Grady. The Resolution was adopted by roll call vote, with Commissioner Boyce abstaining.

Lauren M. Graessle, Deputy Clerk to the Board of Commissioners, read one (1) journalization into the record:

Commissioner O'Grady: Before we move on, I would like to say a few words. The work that we do as County Commissioners is work that we all value.

Commissioner O'Grady (cont.): During the holidays, we had a very impactful situation that we dealt with here in Franklin County with the issue at Sawyer Tower. All of our employees, led by Deputy County Administrator Bivens, really stepped up. We are still working with our partners to deal with the impact of that situation. Our slogan is "every resident, every day," including on Christmas morning. We do this work with our colleagues across the state and across the country. We think about our colleagues across the country on a regular basis because they deal with natural disasters that we do not often have to deal with here in Central Ohio. We have colleagues in South Florida or on the Gulf Shore that are dealing with hurricanes; others who are dealing with wildfires out in the Rockies; and over the last couple of weeks, we have had friends and colleagues from California who are dealing with disaster and flooding from all of the rainfall. The flooding is causing devastation to the infrastructure. People are being impacted by their homes being flooded, but the flooding also impacts the economy in California. People are out of work for an extended period of time because of the disaster they are dealing with. Sonoma County will now have to step up and deal with the impact that the flooding has had on its residents. The work that we do as County Commissioners is the same in every county, whether the counties are poor or rich, red or blue, urban or rural. I just wanted to share that with everybody this morning.

Resolution No. 0037-23, of the Franklin County Board of Commissioners to convene into Executive Session for the purpose of considering personnel matters, to consider the purchase of property, to confer with the Franklin County Prosecutor's Office concerning pending or imminent litigation, and to consider information related to economic development assistance (Board of Commissioners).

Commissioner Crawley moved to approve Resolution 0037-23, to convene into Executive Session to consider the appointment, employment, dismissal, discipline, promotion, demotion, or compensation of a public employee or official. To consider the purchase of property for public purposes. To confer with an attorney for the public body concerning disputes involving the public body that are the subject of pending or imminent court action and, to consider confidential information related to the marketing plans, specific business strategy, production techniques, trade secrets, or personal financial statements of an applicant for economic development assistance, or to negotiations with other political subdivisions respecting requests for economic development assistance, provided that the following conditions apply:

The information is directly related to a request for economic development assistance that is to be provided or administered under any provision of Chapter 715., 725., 1724., or 1728. or sections 701.07, 3735.67 to 3735.70, 5709.40 to 5709.43, 5709.61 to 5709.69, 5709.73 to 5709.75, or 5709.77 to 5709.81 of the Revised Code, or that involves public infrastructure improvements or the extension of utility services that are directly related to an economic development project. Further, that the executive session is necessary to protect the interests of the applicant or the possible investment or expenditure of public funds to be made in connection with the economic

development project, seconded by Commissioner Boyce. The Resolution was unanimously adopted by roll call vote, and the Commissioners convened into Executive Session at 9:49 A.M.

At 11:50 A.M., Commissioner Crawley moved to come out of Executive Session, seconded by Commissioner Boyce, which was unanimously approved by roll call vote. No substantive action was taken upon exiting Executive Session, and with no further business before the Board, the meeting was adjourned at 11:50 A.M.
