MINUTES OF GENERAL SESSION

January 6, 2022

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room, at 9:00 A.M. on Thursday, January 6, 2022.

Commissioner Crawley called the meeting to order at 9:18 A.M.

Commissioner Crawley: Today is January 6; one year since the insurrection at the U.S. Capital. I would like us to spend the day reflecting on the things that took place and the lives that were lost.

Commissioner Boyce moved to approve the minutes, seconded by Commissioner Crawley. The minutes were approved by roll call vote.
