MINUTES OF GENERAL SESSION

September 18, 2023

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room, at 1:00 P.M. on Monday, September 18, 2023.

Present were: John O'Grady, President Kevin L. Boyce, Commissioner Erica C. Crawley, Commissioner

Razek, Clerk to the Board of Commissioners.

Commissioner O'Grady called the meeting to order at 1:02 P.M.

Approval of the minutes for the June 27, July 11, and July 18, 2023, General Sessions; and the July 6, and July 13, 2023, Briefing Sessions. Commissioner Crawley moved to approve the minutes, seconded by Commissioner Boyce. The minutes were unanimously approved by roll call vote.

Resolution No. 0700-23, approving the settlement of legal claims and authorizing the County Administrator to execute a Settlement Agreement and Release and to take additional actions necessary to effectuate the agreement not inconsistent with this Resolution (\$630,000.00) (Prosecuting Attorney), presented by Joseph Durham, Special Counsel, Eastman & Smith.

Mr. Durham reviewed information found in documents submitted with the proposed resolution.

Commissioner Boyce asked for the non-monetary stipulations of the settlement. Mr. Durham stated that Franklin County is already in a consent order with Ohio Environmental Protection Agency (EPA) to address and eliminate household sewage treatment systems by either connecting them to a sanitary sewer or upgrading them to National Pollutant Discharge Elimination Systems (NPDES) compliant systems. Additionally, the County is agreeing to seek funding that assists property owners who need to upgrade or connect to sanitary sewers. There is an annual reporting requirement to the plaintiff's attorney for all reports submitted to the Ohio EPA in response to the consent order. There is also a provision that requires notification to the plaintiff's attorney if the County transfers the ownership or operation of its storm sewer system. Jeanine Hummer, First Assistant Prosecuting Attorney and Chief Counsel, Prosecuting Attorney's Office, asked Mr. Durham to address the letter he received regarding future litigation. Mr. Durham noted that during the terms of this settlement agreement, which is ten years, counsel for Ms. Cox believes they would have a conflict of interest for another action of the same or similar matter.

Commissioner Crawley moved to approve Resolution 0700-23, seconded by Commissioner Boyce. The Resolution was unanimously adopted by roll call vote.
