Commissioner Crawley: Today, we're kicking off National County Government Month, which is celebrated every April to help educate the public about how counties affect their lives and to celebrate the professionals who help serve our residents throughout the year. We also have more staff and commissioners in leadership at the National Association of Counties than any other county in Ohio, and we're going to continue to lead on that national stage for many years to come. We're going to be talking about National County Government month each week at session in April and also on social media to help let our residents know about the services available to them. Our annual State of the County report will be out next week, and we've got lots of other fun and interesting things to share with you about Franklin County as the month goes on.

This week, April 2–April 8 is The Week of the Young Child. The Week of the Young Child® is an annual celebration sponsored by the National Association for the Education of Young Children (NAEYC), the world's largest early childhood education association, with nearly 60,000 members and a network of 52 Affiliates. The purpose of the Week of the Young Child® is to focus public attention on the needs of young children and their families and to recognize the early childhood programs and services that meet those needs.

Also, this week, April 4–April 10 is National Public Health Week. National Public Health Week is observed during the first week of April every year.
