

FRANKLIN COUNTY BOARD OF COMMISSIONERS

MINUTES OF GENERAL SESSION

February 6, 2024

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room, at 9:00 A.M. on Tuesday, February 6, 2024.

Commissioner Boyce called the meeting to order at 9:07 A.M.

Commissioner Boyce: Before we get into our regular agenda, I want to recognize that February is Black History Month, and every year at this time, we honor the contributions and sacrifices of African Americans who have helped shape the nation. Black History Month celebrates the rich cultural heritage, triumphs, and adversities that are an indelible part of our country's history, and when we celebrate Black History Month, we aren't just celebrating Black history; we are celebrating American history, which belongs to all Americans. Despite the struggle, racism, and oppression, we collectively and consciously continue celebrating this history every year to help make the change we want to see in our nation's future. Today, we have Nicole Sutton with us to help celebrate. She is the Black Heritage Special Collections Librarian in Local History & Genealogy with the Columbus Metropolitan Library, and she's going to tell us a little bit about what the library has planned for February and how our residents can get involved.

Nicole Sutton, Black Heritage Special Collections Librarian, Local History & Genealogy, Columbus Metropolitan Library, offered remarks. She explained that her role is to obtain new materials and highlight current materials that exemplify the diversity of Central Ohio, specifically for the Black community. Ms. Sutton provided an overview of the partnerships the library has to work towards this goal.

Ms. Sutton said she hosts the Black Heritage Collection Spotlight, a program held each month. She invites guests to each session to talk about Black history in Columbus, using materials from the library's digital collection. She noted that this program takes place on the first or second Tuesday of every month at noon. She added that they are virtual events, and registration information can be found on the library's website. Ms. Sutton highlighted the events that the library is holding during Black History Month.

Each of the three Commissioners offered remarks, highlighting that Black history is American history. Commissioner Boyce spoke about the County's work to end racism and stated that it starts with knowledge and information. Commissioner Crawley added that she and Commissioner Boyce are a part of Black history and American history, noting that Commissioner Boyce was the first man of color to be a Franklin County Commissioner, and Commissioner Crawley was the first woman of color to do the same. She noted the importance of learning from our history and creating policies for a better and equitable future.

Joy Bivens, Deputy County Administrator, asked if the library has copies of the poll tests that were once used for folks trying to vote. Ms. Sutton stated that some of those tests are available, but not all. Ms. Bivens suggested making those available and using them to educate the residents of Franklin County. She added that those tests eliminated a lot of folks from being able to vote.

Commissioner Boyce offered to have artifacts displayed in the government tower during Black History Month and the rest of the year. Ms. Sutton stated that the Statehouse is currently displaying an Underground Railroad exhibit for the library, so they would love the opportunity to partner with the County in that way, too.

Commissioner Boyce: Next, we have some special guests to help recognize that February is also American Heart Month. As many of you know, cardiovascular disease is the leading cause of death in America, but something you may not know is that women, especially Black and Hispanic women, are disproportionately impacted by heart disease and stroke, and research shows that heart attacks are on the rise in younger women. Here to tell us a little more about American Heart Month and what we all can be doing to be heart healthier is Franklin County Health Commissioner Joe Mazzola. Welcome Commissioner.

Joe Mazzola, Health Commissioner, Franklin County Public Health, introduced Nancy Tobbe, who is the Executive Director of the American Heart Association/American Stroke Association of Central Ohio. Mr. Mazzola spoke about the Franklin County Hypertension Network, which is a group of 30-40 organizations that meet regularly to discuss ways to reduce hypertension in our community. He recognized all of the community partners who are raising awareness during American Heart Month. Ms. Tobbe offered remarks, noting that this year, the American Heart Association is turning 100 years old. She stated that 100 years ago, heart disease was considered to be a death sentence, but through scientific research, advancements, and education, more lives are being saved today.

Ms. Tobbe emphasized the need for continued research, education, and awareness, stating that many people are unaware of the warning signs and risks of cardiovascular disease and stroke. She added that most of these events can be prevented by making healthy lifestyle choices. Ms. Tobbe spoke about the Go Red for Women Initiative, which is celebrating its 20th Anniversary this year. She noted that women are disproportionately impacted by cardiovascular disease, and more women die from cardiovascular disease than they do from all forms of cancer combined.

Each of the three Commissioners offered remarks. Commissioner O'Grady noted that 2024 marks his 25th year of being a heart patient. He reminded everyone to stay on top of their health. Commissioner Boyce stated that Commissioner O'Grady has been an inspiration and an advocate for others, including himself. Commissioner Crawley shared that she has a family history of cardiovascular disease, and she is committed to making healthy lifestyle choices so that she can mitigate her risk. She emphasized that her outcome does not have to be the same as her family members. The Commissioners presented Mr. Mazzola and Ms. Tobbe with a ceremonial resolution recognizing February as Heart Month in Franklin County.

Mr. Foster reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0093-24, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Commissioner Boyce opened the Public Hearing and asked if anyone would like to speak. Seeing and hearing none, Commissioner Boyce closed the public hearing, and the resolution was read into the record.

Resolution No. 0096-24, the 2024 Resurfacing Program for Franklin County, Ohio, declared necessary and hearing fixed for Tuesday, February 27, 2024, at 9:00 A.M. (Engineer), presented by Brad Foster, Engineer, Engineer's Office.

Mr. Foster reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0096-24, seconded by Commissioner O’Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0097-24, final encumbrance of County Motor Vehicle License Fee (\$5) Funds to the City of Worthington (Engineer), presented by Brad Foster, Engineer, Engineer’s Office.

Mr. Foster reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0097-24, seconded by Commissioner O’Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0098-24, requesting the Ohio Department of Transportation to reduce the speed limit on Harlem Road, County Road No. 111, Plain Township, Franklin County, Ohio (Engineer), presented by Brad Foster, Engineer, Engineer’s Office.

Mr. Foster reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0098-24, seconded by Commissioner O’Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0099-24, authorizing acceptance of a grant of funds from the Ohio Suicide Prevention Foundation for the Suicide Investigator position within the Franklin County Coroner’s Office and authorizing the County Administrator to sign the agreement (\$200,000.00) (Coroner), presented by Amanda Alvarez Wright, Director of Operations, Coroner’s Office, and Dallas Allen, Suicide Investigator and Postvention Specialist, Coroner’s Office.

Ms. Wright and Mr. Allen reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley stated that the Board of Commissioners supports organizations that focus on behavioral health and mental health, and they are trying to break the stigma around these topics, especially in communities of color. She asked that the team at the Coroner’s Office relay any requests or information they receive from families of loved ones who have been lost to suicide so that the Board can determine what more they can do to provide better resources to people struggling with mental health issues. She emphasized that feedback is crucial to offering the right support. Mr. Allen stated that he has approximately 200 actionable recommendations that could make a positive impact on the community regarding suicide fatalities. He explained that he is trying to determine the best way to implement those recommendations, adding that he has positioned the Franklin County Suicide Prevention Coalition as the actionable arm for those recommendations. He stated that any support from the Commissioners would be greatly appreciated.

Commissioner Crawley stated that she sits on the Coalition and she appreciates all of the work that they are doing. She thanked Mr. Allen for supporting that organization and their work. Kris J. Long, Deputy County Administrator, asked that the Coroner's Office forward the recommendations to each of the Commissioners' offices and County Administration so they could disseminate the information appropriately. Mr. Allen stated that he is creating a data report that he will disseminate, which he hopes to complete by April.

Commissioner Crawley moved to approve Resolution 0099-24, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0100-24, agreement with OhioHealth to provide tuberculin tests for employees (\$1,680.00) (Coroner), presented by Amanda Alvarez Wright, Director of Operations, Coroner's Office.

Ms. Wright reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0100-24, seconded by Commissioner O'Grady. The Resolution was adopted by roll call vote, with Commissioner Boyce abstaining.

Resolution No. 0101-24, authorizing a five-year contract between the Franklin County Board of Commissioners, on behalf of the Franklin County Department of Animal Control and the City of Columbus, Department of Public Health for rabies control and testing services (\$10,440.00) (Animal Control), presented by Lionel Hamilton II, Fiscal Officer, Animal Control.

Mr. Hamilton reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0101-24, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0102-24, authorizing a grant agreement with Rev1 Ventures to provide grants, training, and assistance to women and diverse entrepreneurs (\$230,000.00) (Office of Diversity Equity & Inclusion), presented by Damika Withers, Chief Economic Equity and Inclusion Officer, Office of Diversity Equity and Inclusion.

Ms. Withers reviewed information found in documents submitted with the proposed resolution.

Joy Bivens, Deputy County Administrator, asked how women in the community can find this resource. Kristy Campbell, Executive Vice President and Chief Operations Officer, Rev1 Ventures, stated that between their partnership with Aventi and their work directly in the community, Rev1 promotes these accelerators. She stated that there are websites that

communicate the benefits of entrepreneurs being able to explore technology for their businesses.

Commissioner Crawley moved to approve Resolution 0102-24, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0103-24, authorizing an Office of Diversity, Equity, and Inclusion Agreement with the Greater Columbus Sports Commission to support economic equity in Columbus and Franklin County to encourage economic development and tourism through the attraction, retention, and promotion of sporting events on behalf of Franklin County Board of Commissioners (\$130,000.00) (Office of Diversity Equity & Inclusion), presented by Damika Withers, Chief Economic Equity and Inclusion Officer, Office of Diversity Equity and Inclusion.

Ms. Withers reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0103-24, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0121-24, authorizing a funding agreement between the Franklin County Board of Commissioners and The Community Builders to expand the supply of affordable housing in Franklin County (Economic Development and Planning), presented by Brianna T. Morris, Assistant Prosecuting Attorney, Prosecuting Attorney's Office.

Ms. Morris reviewed information found in documents submitted with the proposed resolution.

Commissioner Boyce stated that last week, he testified about affordable housing before the United States Senate Budget Committee. He noted that he was able to highlight some of the work that Franklin County has been able to do using HOME funds. He suggested that the Prosecutor's Office and EDP coordinate with his office to draft a letter highlighting how Franklin County has used HOME funds. Commissioner Crawley asked if this was the Bexley project with historical components. Ms. Morris replied in the affirmative but clarified that the part of the project Commissioner Crawley was referring to was on East Livingston Avenue, and the resolution before them today would specifically go towards the project on Cassidy Avenue. Kenneth N. Wilson, County Administrator, confirmed that information and thanked Ms. Morris for her work on this project.

Commissioner Crawley moved to approve Resolution 0121-24, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0104-24, review of petition to annex 9.45 +/- acres from Jackson Township to the City of Columbus Case #ANX-02-24 (Economic Development and Planning), presented by Emanuel Torres, Assistant Director, Economic Development and Planning.

Mr. Torres reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0104-24, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

(\$3,291,208.28) (Job and Family Services), presented by Walter Dillard, Assistant Director and Chief Strategy Officer, Job and Family Services.

Mr. Dillard reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0108-24, seconded by Commissioner O'Grady. The Resolution was adopted by roll call vote, with Commissioner Boyce abstaining.

Mr. Dillard reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley stated that the Board of Commissioners has been a long-term supporter of these services, and she would love to see the amount increased a little. She shared that when she was in law school, she volunteered with the Volunteer Income Tax Assistance Program, which was supported by United Way. She noted that the taxes she prepared were mainly for aging residents and low-income individuals, and these services make a huge difference. She added that many of them had missed tax deadlines before because they did not have the money or resources to file them, but when they were able to use these resources, they got some extra money in their pockets because many of them received tax returns.

Commissioner Crawley moved to approve Resolution 0110-24, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Commissioner Crawley moved to approve Resolution 0112-24, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0113-24, authorizing a final contract modification with Elite Excavating Company of Ohio, Inc. to close out the Young Estates Pump Station Replacement Project for a decrease of \$39,623.74 (\$630,142.26) (Sanitary Engineers), presented by Ryan Stowe, Assistant Director, Sanitary Engineers.

Mr. Stowe reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0113-24, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0114-24, authorizing a final contract modification with Darby Creek Excavating, Inc. to close out the Timberlake Water System Improvements Project for a decrease of \$17,977.13 (\$123,324.87) (Sanitary Engineers), presented by Ryan Stowe, Assistant Director, Sanitary Engineers.

Mr. Stowe reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0114-24, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0115-24, authorizing a guaranteed maximum price (GMP) Amendment #5 to modify the original contract agreement with Elford, Inc. to provide construction manager at risk services, including construction services, associated with the construction of the Franklin County Domestic Relations and Juvenile Court in the amount of the contract not to exceed \$15,047,704.00 (\$36,675,949.53) (Public Facilities Management), presented by Darla Reardon, Director, Public Facilities Management.

Ms. Reardon reviewed information found in documents submitted with the proposed resolution.

Ms. Perry-Balonier and Ms. Withers reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0116-24, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0117-24, approving purchases for various Franklin County agencies (\$182,800.00) (Purchasing), presented by Megan Perry-Balonier, Director, Purchasing.

Ms. Perry-Balonier reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0117-24, seconded by Commissioner O'Grady. The Resolution was adopted by roll call vote, with Commissioner Boyce abstaining.

Resolution No. 0118-24, to designate the Official Representative and Alternate for the purpose of voting at the Annual Meeting of the County Commissioners Association of Ohio in 2024 (Board

of Commissioners), presented by Lauren M. Graessle, Assistant Director of Community Appointments, Board of Commissioners.

Ms. Graessle reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0118-24, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0119-24, appointing LaGrieta Acheampong as a Member-at-Large to the Mid-Ohio Regional Planning Commission. (Board of Commissioners), presented by Lauren M. Graessle, Assistant Director of Community Appointments, Board of Commissioners.

Ms. Graessle reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley moved to approve Resolution 0119-24, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0120-24, of the Franklin County Board of Commissioners to convene into Executive Session for the purpose of considering personnel matters (Board of Commissioners).

Commissioner Crawley moved to approve Resolution 0120-24, to convene into Executive Session to consider the appointment, employment, dismissal, discipline, promotion, demotion, or compensation of a public employee or official, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote, and the Commissioners convened into Executive Session at 10:33 A.M.

At 2:16 P.M., Commissioner Crawley moved to come out of Executive Session, seconded by Commissioner O'Grady, which was unanimously approved by roll call vote. No substantive action was taken upon exiting Executive Session, and with no further business before the Board, the meeting was adjourned at 2:16 P.M.


