MINUTES OF GENERAL SESSION

March 2, 2021

The Franklin County Board of Commissioners convened the General Session meeting via Zoom conferencing, at 9:00 A.M. on Tuesday, March 2, 2021.

President Boyce called the meeting to order at 9:01 A.M.

President Boyce: As you all know, March is Women's History Month; we had a great Black History Month in February. I think we are headed for the tremendous recognition of the legacy and contribution of many women in this great country. March is dedicated as Women's History Month to reflect on the often-overlooked contributions women have made building this country. Expect guests throughout March that will enlighten us on empowering women and promoting gender equality in our community. Today, we have with us Tammy Wharton who is President and CEO of Girl Scouts of Ohio's Heartland. She leads one of the strongest memberships among Girl Scout Councils and brings an emotional intelligence to her work. She teaches girls courage, confidence and character, and about making the world a better place.

Tammy Wharton, President and CEO, Girl Scouts of Ohio's Heartland, shared the detailed history of the Girl Scouts; presenting a PowerPoint presentation of the Girl Scouts of Ohio's rich history.

Approval of the minutes of the February 23, 2021, General Session; the February 25, 2021, Briefing Session; and, the February 22, and 24, 2021, Administrative Briefings. Commissioner Brown moved to approve the minutes, seconded by Commissioner O'Grady. The minutes were unanimously approved by roll call vote.

Resolution No. 0160-21, authorizing a Grant Agreement between the Board of Commissioners and IMPACT Community Action for rental assistance and eviction prevention in Franklin County (\$2,000,000.00) (Economic Development and Planning), presented by Jenny Snapp, Assistant Director, Economic Development and Planning.

Ms. Snapp reviewed information found in documents submitted with the proposed resolution.

Robert "Bo" Chilton, President and CEO, IMPACT Community Action, addressed the Board in support of the proposed resolution.

Commission Brown: What way can people can get in touch with you if they don't have access to technology?

Mr. Chilton: They can call our number at (614) 252-2799. We do take on-site appointments and we're at eviction court, so for people who have cases there, we encourage them to show up because we can then intervene and give them a conditional assistance once we get a full application.

Mr. Hindenlang: Mr. Chilton, could you please repeat that phone number?

Resolution No. 0161-21, authorizing a Service Agreement between the Board of Commissioners and the Community Shelter Board to develop and implement strategies that decrease homelessness in Franklin County (\$500,000.00) (Economic Development and Planning), presented by Mark Paxson, Community Development Administrator, Economic Development and Planning.

Mr. Paxson reviewed information found in documents submitted with the proposed resolution.

Michelle Heritage, Executive Director, Community Shelter Board, addressed the Board in support of the proposed resolution.

Commissioner Brown moved to approve Resolution 0161-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0162-21, awarding a Service Agreement between the Board of Commissioners and the Community Shelter Board to provide shelter and housing services to homeless Franklin County residents (\$50,100.00) (Economic Development and Planning), presented by Mark Paxson, Community Development Administrator, Economic Development and Planning.

Mr. Paxson reviewed information found in documents submitted with the proposed resolution.

Commissioner Brown moved to approve Resolution 0162-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0163-21, authorizing the County Administrator to execute all Bureau of Motor Vehicles documents necessary to obtain, renew, maintain, and transfer license plates and vehicle registrations for County vehicles (Fleet Management), presented by Charlotte Ashcraft, Director, Fleet Management.

Ms. Ashcraft reviewed information found in documents submitted with the proposed resolution.

Commissioner Brown moved to approve Resolution 0163-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0164-21, approving a subaward amendment with Asian American Community Services for Out-of-School Time youth programming (\$62,151.00) (Job and Family Services), presented by Vivian Turner, Assistant Director, Job and Family Services.

Ms. Turner reviewed information found in documents submitted with the proposed resolution.

Elyse McConnell, Director of Family Support Programs, Asian American Community Services (AACS), addressed the Board in support of the proposed resolution.

Commissioner Brown moved to approve Resolution 0164-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0165-21, approving purchases for various Franklin County agencies (\$6,047,247.22) (Purchasing), presented by Megan Perry-Balonier, Director, Purchasing.

Commissioner Brown moved to approve Resolution 0165-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.
