MINUTES OF GENERAL SESSION

March 9, 2021

The Franklin County Board of Commissioners convened the General Session meeting via Zoom conferencing, at 9:00 A.M. on Tuesday, March 9, 2021.

President Boyce called the meeting to order at 9:01 A.M.

President Boyce: As a reminder, March is Women's History Month. What an exciting month it has been learning and growing with regards to the legacy that women have been a part of in this great country. My colleagues and I think we have set the tone of the last few years with our own level of inclusion and how we go about our everyday work. As such, a few years ago we created the New American Advisory Council, which was created to promote integration and community engagement among a growing immigrant and refugee population. Our guest today is Nadia Kasvin. Nadia is the co-founder and Director of US Together; founded in 2003, now in their eighteenth year. She herself is a former refugee from Ukraine. She has spent over thirty-five years coordinating support for vulnerable women, children, seniors and refugees among the new American population in Franklin County. Currently serving three locations, Columbus, Cleveland and Toledo. Nadia's work and vision are an excellent example of refugees serving refugees.

Nadia Kasvin, Co-Founder and Director, US Together, shared the detailed history, experiences, and ways that US Together empowers women.

Resolution No. 0177-21, authorizing the County Administrator to execute a modification to the contract agreement with Johnson Controls Fire Protection LP to perform additional security electronics activities associated with the construction of the Franklin County Corrections Center in the amount of the contract not to exceed \$75,000.00, and authorizing the County Administrator to approve and execute additional minor modifications to the contract agreement (\$9,463,214.00) (Public Facilities Management), presented by Darla Reardon, Director, Public Facilities Management.

Resolution No. 0179-21, authorizing the County Administrator to execute a modification to the contract agreement with OCP Contractors, Inc. to perform additional acoustical and drywall activities associated with the construction of the Franklin County Corrections Center in the amount of the contract not to exceed \$277,072.00, and authorizing the County Administrator to approve

and execute additional minor modifications to the contract agreement (\$5,614,842.00) (Public Facilities Management), presented by Darla Reardon, Director, Public Facilities Management.

Ms. Reardon reviewed information found in documents submitted with the proposed resolution.

Commissioner O'Grady moved to approve Resolution 0179-21, seconded by Commissioner Brown. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0180-21, authorizing the County Administrator to execute a modification to the contract agreement with S.A. Comunale Co., Inc. to perform additional fire protection activities associated with the construction of the Franklin County Corrections Center in the amount of the contract not to exceed \$63,527.00, and authorizing the County Administrator to approve and execute additional minor modifications to the contract agreement (\$1,892,727.00) (Public Facilities Management), presented by Vivian Alexander, Chief Operating Officer, Public Facilities Management.

Ms. Alexander reviewed information found in documents submitted with the proposed resolution.

Commissioner O'Grady moved to approve Resolution 0180-21, seconded by Commissioner Brown. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0181-21, authorizing the County Administrator to execute a modification to the contract agreement with Wanner Metal Worx, Inc. to perform additional miscellaneous steel activities associated with the construction of the Franklin County Corrections Center in the amount of the contract not to exceed \$421,094.00, and authorizing the County Administrator to approve and execute additional minor modifications to the contract agreement (\$5,256,602.00) (Public Facilities Management), presented by Darla Reardon, Director, Public Facilities Management.

Ms. Reardon reviewed information found in documents submitted with the proposed resolution.

Commissioner O'Grady moved to approve Resolution 0181-21, seconded by Commissioner Brown. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0182-21, approving purchases for various Franklin County agencies (\$1,456,201.87) (Purchasing), presented by Megan Perry-Balonier, Director, Purchasing.

Ms. Perry-Balonier reviewed information found in documents submitted with the proposed resolution.

Commissioner O'Grady moved to approve Resolution 0182-21, seconded by Commissioner Brown. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0183-21, authorizing a one-year contract with Future Ready Columbus in support of the Future Ready by 5 kindergarten readiness plan (\$400,000.00) (Board of Commissioners), presented by Dayna McCrary, Administrator, Community Partnerships.

Ms. McCrary reviewed information found in documents submitted with the proposed resolution.

Jane Leach, Executive Director, Future Ready Columbus, addressed the Board in support of the proposed resolution.

Commissioner O'Grady moved to approve Resolution 0183-21, seconded by Commissioner Brown. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0184-21, resolution of the Franklin County Board of Commissioners to convene into Executive Session for the purpose of considering personnel matters (Board of Commissioners).

Commissioner O'Grady moved to approve Resolution 0184-21, for the purpose of considering personnel matters, seconded by Commissioner Brown. The Resolution was unanimously adopted by roll call vote and the Commissioners convened into Executive Session at 9:57 A.M.

At 11:53 A.M., Commissioner O'Grady moved to come out of Executive Session, with President Boyce seconding, which was approved by roll call vote. No action was taken upon exiting Executive Session, and with no further business before the Board, the meeting was adjourned at 11:53 A.M.
