## MINUTES OF GENERAL SESSION

## March 30, 2021

The Franklin County Board of Commissioners convened the General Session meeting via Zoom conferencing, at 9:00 A.M. on Tuesday, March 30, 2021.

## Present were: President Kevin L. Boyce Marilyn Brown, Commissioner John O'Grady, Commissioner

Also present were Jeanine Hummer, First Assistant Prosecuting Attorney, Prosecuting Attorney's Office; Kenneth N. Wilson, County Administrator; and, Dean M. Hindenlang, Clerk to the Board of Commissioners, amongst others.

President Boyce called the meeting to order at 9:01 A.M.

President Boyce: In our ongoing celebration of Women's History Month, welcome Christie Angel, President and CEO, of the YWCA of Columbus. Ms. Angel has held several leadership positions in local government, non-profits, and the private sector throughout Central Ohio, and has led the YWCA since 2017. She serves on numerous boards and is a daily advocate for homeless women and children in Franklin County. Here to tell us more about that and discuss her leadership experiences is our good friend, Christie Angel.

Christie Angel, President and CEO, YWCA of Columbus, shared her experiences working for the YWCA and her leadership experiences in honoring women, during Women's History Month.
