## MINUTES OF GENERAL SESSION

April 13, 2021

The Franklin County Board of Commissioners convened the General Session meeting via Zoom conferencing, at 9:00 A.M. on Tuesday, April 13, 2021.

Present were: Marilyn Brown, Commissioner John O'Grady, Commissioner

Commissioner Brown called the meeting to order at 9:00 A.M.

Commissioner Brown: Since 1991 we have recognized National County Government month by highlighting all the services and programs counties provide their residents. The coronavirus pandemic has offered a real-life example of the important role county governments play as local health departments have worked tirelessly to protect public health and reduce the spread of infectious diseases. This morning, we wish to congratulate and offer our sincere appreciation to Health Commissioner, Joe Mazzola, and our dedicated health care partners at Franklin County Public Health for the exceptional work they have done to maintain our community's public health over the past year. As we wrap up National Public Health Week, we thank you on behalf of all Franklin County residents.

Commissioner Brown (cont.): We are also celebrating Week of the Young Child, as we learn more about brain development it has become clear that early childhood learning is just as important as the K-12 education in a child's development. Since 2017, my colleagues and I have committed more than \$4.5 million to help increase the community awareness about the importance of high-quality early learning and ensure publicly funded childcare providers earned their stars under Ohio's Step Up to Quality rating improvement system. Commissioner Brown (cont.): In addition, we are recognizing Black Maternal Health Week, as Franklin County has a long-standing commitment to reducing infant mortality and racial disparities in health outcomes, it's embedded in our Rise Together Blueprint and in our declaration of racism as a public health crisis. Since 2013 the Board of Commissioners has been a founding member of the Greater Columbus Infant Mortality Task Force and has been a lead partner in the CelebrateOne initiatives since its inception.

The Commissioners welcomed the Ohio High School Athletic Association (OHSAA), the Greater Columbus Sports Commission, and the Central Ohio Winter State Champions. Students from Columbus School for Girls, Dublin Scioto, Upper Arlington, Olentangy Liberty, Gahanna Lincoln, Dublin Coffman, New Albany, Lewis Center Olentangy, Westerville North, and Hilliard Darby were recognized for their achievements within their respective sports. Each student was offered the opportunity to introduce themselves and noted their intentions for the next academic year.
