MINUTES OF GENERAL SESSION

April 20, 2021

The Franklin County Board of Commissioners convened the General Session meeting via Zoom conferencing, at 9:00 A.M. on Tuesday, April 20, 2021.

President Boyce called the meeting to order at 9:03 A.M.

President Boyce: This week we join other leaders across the globe to pay tribute to Earth Day. Commissioner Brown moved to approve Resolution 0282-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0283-21, AECOM Technical Services, Inc., consulting engineers appointed to assist the Franklin County Engineer by providing engineering services for the Koebel Baird Rainier Drainage Improvement project, Franklin County, Ohio (\$74,903.15) (Drainage Engineer), presented by Cornell Robertson, Engineer, Engineer's Office.

Commissioner Brown moved to approve Resolution 0283-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0284-21, S&ME, Inc., consulting engineers appointed to assist the Franklin County Engineer by providing general construction inspection services, Franklin County, Ohio (\$100,000.00) (Engineer), presented by Cornell Robertson, Engineer, Engineer's Office.

Commissioner Brown moved to approve Resolution 0284-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0285-21, LJB, Inc., consulting engineers appointed to assist the Franklin County Engineer in performing preliminary engineering for the Cleveland Avenue from Huy Road to Cooke Road Improvement project, Franklin County, Ohio (\$186,113.00) (Engineer), presented by Cornell Robertson, Engineer, Engineer's Office.

Commissioner Brown moved to approve Resolution 0285-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0292-21, authorizing a IV-D contract with the Franklin County Prosecutor's Office (\$285,334.04) (Child Support Enforcement), presented by Susan Brown, Director, Child Support Enforcement.

Commissioner Brown moved to approve Resolution 0292-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0293-21, review of a petition to annex 4.75 +/- acres from Blendon Township to the City of Columbus, Case #ANX-07-21 (Economic Development and Planning), presented by Jenny Snapp, Assistant Director, Economic Development and Planning.

Ms. Snapp reviewed information found in documents submitted with the proposed resolution.

Commissioner Brown moved to approve Resolution 0293-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0294-21, approving a contract with Raising the Bar Performance Group for race equity consulting services (\$120,000.00) (Job and Family Services), presented by Vivian Turner, Assistant Director, Job and Family Services.

Ms. Turner reviewed information found in documents submitted with the proposed resolution.

Commissioner Brown moved to approve Resolution 0294-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0295-21, authorizing a modification to the contract agreement with ms consultants, inc. to provide professional civil engineering services associated with the planning, design and construction of the Franklin County Corrections Center at an increase in the amount of the contract not to exceed \$65,500.00 (\$1,247,399.00) (Public Facilities Management), presented by Darla Reardon, Director, Public Facilities Management.

Ms. Reardon reviewed information found in documents submitted with the proposed resolution.

Commissioner Brown moved to approve Resolution 0295-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0296-21, authorizing the County Administrator to execute a modification to the contract agreement with Johnson Controls Fire Protection LP to perform additional security electronics activities associated with the construction of the Franklin County Corrections Center in the amount of the contract not to exceed \$4,455,317.00 and authorizing the County Administrator to approve and execute additional minor modifications to the contract agreement

(\$13,918,531.00) (Public Facilities Management), presented by Darla Reardon, Director, Public Facility Management.

Ms. Reardon reviewed information found in documents submitted with the proposed resolution.

President Boyce: Do we have an opening date set?

Ms. Reardon: Substantial completion is scheduled for June, and then phased-in openings, thereafter.

Commissioner Brown moved to approve Resolution 0296-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0297-21, approving purchases for various Franklin County agencies (\$2,203,687.91) (Purchasing), presented by Megan Perry-Balonier, Director and Marliese Wicker, Small Emerging Business Coordinator, General Services.

Ms. Wicker reviewed information found in documents submitted with the proposed resolution.

Commissioner Brown moved to approve Resolution 0297-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Resolution No. 0298-21, Resolution of the Franklin County Board of Commissioners to convene into Executive Session for the purpose of considering personnel matters, and to confer with the Franklin County Prosecutor's Office concerning pending or imminent litigation (Board of Commissioners).

Commissioner Brown moved to approve Resolution 0298-21, to convene into Executive Session to consider the appointment, employment, or compensation of a public employee and to confer with an attorney for the public body concerning disputes involving the public body that are the subject of pending or imminent court action, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote and the Commissioners convened into Executive Session at 9:52 A.M.

At 12:03 P.M., Commissioner Brown moved to come out of Executive Session, with Commissioner O'Grady seconding, which was unanimously approved by roll call vote. No action was taken upon exiting Executive Session, and with no further business before the Board, the meeting was adjourned at 12:03 P.M.
