MINUTES OF GENERAL SESSION

May 11, 2021

The Franklin County Board of Commissioners convened the General Session meeting via Zoom conferencing, at 9:00 A.M. on Tuesday, May11, 2021.

Commissioner O'Grady called the meeting to order at 9:01 A.M.

Approval of the minutes of the May 4, 2021, General Session; the May 6, 2021, Briefing Session; and, the May 3, and 5, 2021, Administrative Briefings. Commissioner Brown moved to approve the minutes, seconded by Commissioner O'Grady. The minutes were approved by roll call vote.
