MINUTES OF GENERAL SESSION

June 15, 2021

The Franklin County Board of Commissioners convened the General Session meeting via Zoom conferencing, at 9:00 A.M. on Tuesday, June 15, 2021.

Commissioner O'Grady called the meeting to order at 9:02 A.M.

Commissioner John O'Grady: In celebration of this week's Juneteenth holiday I'd like to introduce our guest, Dr. Hasan Jeffries, 20th century African American history professor at The Ohio State University teaching civil rights, and author of "*Bloody Lowndes: Civil Rights and Black Power in Alabama's Black Belt*" and "*In the Shadow of Civil Rights*." If you could please share with our listening audience, the history of June 19th and the relevance it holds today that would be helpful. If you could also touch on the work, you believe, that still needs to be done for the promise that, "all people are created equal under law," to become a reality that would also be appreciated. Good morning, Dr. Jeffries, and welcome.

Dr. Hasan Jeffries, African American history professor at The Ohio State University, shared the history of June 19th and his work for the promise that, "all people are created equal under law," to become a reality, in honor of the Juneteenth holiday.

Commissioner O'Grady and Commissioner Tyler Lee, both shared comments and thanked to Dr. Jeffries for his expertise and time.
