## FRANKLIN COUNTY BOARD OF COMMISSIONERS

## MINUTES OF GENERAL SESSION

## January 26, 2021

The Franklin County Board of Commissioners convened the General Session meeting via Zoom conferencing, at 9:00 A.M. on Tuesday, January 26, 2021.

Present were: President Kevin L. Boyce Marilyn Brown, Commissioner John O'Grady, Commissioner

Also present were Jeanine Hummer, First Assistant Prosecuting Attorney, Prosecuting Attorney's Office; Kenneth N. Wilson, County Administrator; Zachary Talarek, Director, Office of Management & Budget; and, Dean M. Hindenlang, Clerk to the Board of Commissioners, amongst others.

President Boyce called the meeting to order at 9:03 A.M.

Approval of the minutes of the January 19, 2021, General Session; the January 21, 2021, Briefing Session; and, the January 20, 2021, Administrative Briefing. Commissioner Brown moved to approve the minutes, seconded by Commissioner O'Grady. The minutes were unanimously approved by roll call vote.

President Boyce: Good morning, it is my great honor to introduce two distinguished guests of the Franklin County family, and more specifically the Clippers Baseball Organization. Frank Ray served forty-five years as Special Assistant to the county's prosecutor's office. Since 1976, he led counsel in creating the Columbus Clippers Triple A Baseball Team. All aspects of creating Huntington Park, opened in April of 2009. He is an award-winning litigator, impacting people's civil rights, and he is a charismatic, dynamic, and hardworking mediator. He is currently an adjunct professor at The Ohio State University, Moritz College of Law.

President Boyce (cont.): Janica Pierce-Tucker's appointment as the top legal counsel for the Clippers could well be and probably is the first such appointment of an African American woman to a C-level position in the history of organized American professional baseball. She currently is managing partner of Taft, Stettinius & Hollister; serves as the first black woman to lead a Columbus Law Firm. She is a 1999 University of Tennessee, and 2002 OSU Law School graduate. She is a civil rights scholar, advocate and well-deserving of this appointment.

The commissioners, as well as Prosecuting Attorney G. Gary Tyack, and First Assistant Prosecuting Attorney Jeanine Hummer each commented on Frank Ray's service, and in support of the appointment of Janica Pierce-Tucker.

**Resolution No. 0048-21**, recognizing the appointment of Janica A. Pierce Tucker and Frank A. Ray as Special Assistants to the Prosecuting Attorney regarding the Franklin County Parks and Recreation Board, and the Parks Board's non-profit corporations, Franklin County Stadium, Inc., and Columbus Baseball Team, Inc. (Board of Commissioners), presented by Kris Long, Deputy County Administrator, Board of Commissioners.

Ms. Long reviewed information found in documents submitted with the proposed resolution.

[Public Speaker Slip] Nana Watson, President, NAACP Columbus, Ohio: The NAACP is pleased to learn of the appointment of Janica Pierce-Tucker, congratulations and to you Frank Ray, as well. I'm not here to oppose the appointments. I am here to request the Prosecutor's Office take as much time and thought into asking for this appointment as they would and should to employ blacks in key positions in the Prosecutor's Office. A promise was made that the Prosecutor's Office would reflect the community; the black community. We believe the black community propelled the Prosecutor to his victory. The county's population is twenty-four percent African American. There are two-hundred twenty-one full-time employees in the Prosecutor's Office, and we need to look at that. As of today, the top administrators are not black. This is extremely disappointing to the NAACP. Promises made, but not kept. Your NAACP is asking that the Commissioners join us in monitoring the Prosecutor's Office in terms of employing blacks in top leadership roles within the department. The appointees that you just appointed, the individuals you just appointed are not going to be housed in the Prosecutor's Office, they're still going to be attached to their law firms. We are really concerned about this, because racism is a public health crisis.

President Boyce: Thank you, Ms. Watson. You're always a voice for equality and equity, and we value that more than we tell you and so that's welcome here. While this resolution is about Janica Tucker, your concerns are certainly noted. Prosecutor Tyack is here, and Jeanine Hummer is here. I would offer you an opportunity to make a few comments if you want Prosecutor Tyack, but I do want to remind everyone that this is not the topic of this resolution. If you want to, you can. I would encourage you to set up a follow-up meeting with Ms. Watson and I'm happy to participate.

Prosecutor Tyack: Ms. Watson, we can't know now, how hard we are working on trying to racially balance the office, which was very out of balance under my predecessor. We are working each day. We have a little problem in that the money that is required, although the Commissioners have been very generous, doesn't allow us to hire some of the people we want away from private practice. We can't pay them that much. I am very aware of your concerns and we are going to consistently address them and try to racially balance that office.

Commissioner Brown moved to approve Resolution 0048-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Mr. Schimmer reviewed information found in documents submitted with the proposed resolution.

Commissioner Brown: I know that Tom Walker and Christy Campbell have been working to increase the number of minority businesses in this space. Can you talk about where you are with that?

Tom Walker, President and Chief Executive Officer, Rev1: Our 2020 data is that we had forty-four newly engaged clients last year, and twenty-six of those or fifty-nine percent were minority companies. The way that breaks out is eleven were women-led, and eighteen were minority-led. Regarding the eighteen minority-led, forty-four percent or eight of them were Asian-led companies, thirty-nine percent or seven were black-led. Eleven percent or two, were Hispanic, and the remaining were unknown. So, it is an area that we continue to work, and we have new programs for this year as well.

Commissioner Brown moved to approve Resolution 0064-21, seconded by Commissioner O'Grady. The Resolution was unanimously adopted by roll call vote.

Commissioner Brown: With the pandemic still with us, I know that you've been working to maintain the relationships with our sister cities. Could you talk about what you've been doing over this past year and during the pandemic?

Jayme Staley, Executive Director, Sister Cities: While the pandemic has limited our ability to travel to some of our sister cities, I would tell you that our relationship with those sister cities have never been stronger. For the first time in the history of Franklin County and all our sister cities around the world, everyone was facing the exact same challenge at the exact same moment. We were able to share not only best practices for how we were managing those different challenges throughout the course of the year, but also resources.

Joy Bivens, Deputy County Administrator, Health and Human Services: When we went down this trajectory two or three years ago, we identified that sixty-eight percent children of color would be impacted significantly if this investment was not made. When we started, we were at twenty-four percent of star rated centers. To date, we are I believe at ninetyseven percent. So, I wanted to commend you on your generous efforts.

Ms. Turner: Director, they were able to help us get to ninety-nine percent.
