MINUTES OF GENERAL SESSION

February 22, 2022

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room, at 9:00 A.M. on Tuesday, February 22, 2022.

Commissioner Crawley called the meeting to order at 9:09 A.M.

Commissioner Crawley: Our next guest for Black History Month is the leader of the King Arts Complex, which continues to be an integral part of the African American community in Franklin County. The King Arts Complex has connected the community through the arts. We have been featuring some of those works this month along the first-floor hallways of the county building. With us today is the King Arts Complex's Executive Director, Demetries Neely, who has some community history to share.

Mr. Schimmer reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley: At Briefing Session last Thursday, I asked about outcomes and measurements for this year, which I can see is in Exhibit A, but I asked about last year as

well and I have not seen that yet to be able to compare. Is there someone that is on the call that can speak to this, but I wanted to know based on last year and the contribution from the County to the Shelter Board, in our efforts to decrease homelessness, how many persons were served with permanent housing?

Michelle Heritage, Executive Director, Community Shelter Board: We served 2,643 people that were placed in permanent housing units, and the number of persons rehoused last year into the market was 867. In homeless prevention, we do one of two things: try to preserve the current housing, if it's stable, or if the housing is unstable, we rehouse folks. Most of the folks we served in unstable housing and rehoused were families with three or four children, pregnant women, or veterans, which accounted for 560 households.

Commissioner Crawley: Thank you. In regards to the rapid rehousing, for this year's goal of serving 2,000 households, could you please talk about the data from last year and how you got to the number of serving 2,000 households this year? Or how that goal came to be based on 867 being served last year?

Ms. Heritage: What we saw last year with the partner agencies that were engaged in the rapid rehousing was a couple things happening. One thing was that it was the second year in a row where it was very difficult to rehouse. That rehousing difficulty comes from the lack of affordable housing. We are seeing the monthly cost of housing units really escalate, which makes it difficult for folks to find decent, safe, and affordable housing. Often times, the housing that is left and affordable, is not in fact decent or safe for them. We also had a lot of challenges reported to us from the partner agencies, which included trying to get Social Security cards or IDs for people, which had to do with shutdowns. We also saw there was not as much movement in the rental properties as we had seen in the past. What we are hoping for is that we do not have another surge with another pandemic variant, so we can go back to a more normalized way of being able to do this work without so many barriers. In combination with assistance from the federal and state government, and others, we are able to provide more resources for our partner agencies, and that is how we got to that number based on past years.

Commissioner Crawley: Thank you. At Briefing, Deputy County Administrator, Erik Janas, asked about some information regarding veterans. Veterans are near and dear to my heart, as well as homelessness, and I am a veteran. Homelessness is complex for our homeless population, but especially for veterans. I know you have helped several veterans find permanent housing, but I would like to see a place where we can get to functional zero. Can you please talk to us about how we can get to a place considered to be functional zero when it comes to housing veterans?

Ms. Heritage: We work very closely with our Veterans Administration (VA) on achieving this functional zero. One of the challenges we have had is that our veteran population is quite low. To get to a functional zero, one of the things you have to do is have more veterans getting housed than veterans becoming homeless. One of the challenges we have is when the community grows as fast as we are, and we have so many people moving in to get them

pushed through. Often, we will touch functional zero, be there for a while, and then go back up again. The other thing that we have decided to do that we think is very important is that when communities offer a veteran housing several times, they will then take that veteran off the list of veterans that are "homeless." We have decided that is not the right approach. As a result, regardless of how many times we offer them housing, whether one or one hundred times, we will continue to work with our veterans for as long as it takes to get them housed. So, some numbers in some communities have decreased because of how things are counted; we have decided not to do that because we want to ensure we have a true functional zero.

Commissioner Crawley: Thank you. When it comes to the Veteran Services Commission here in the county, last year, they supported hundreds of veterans with rent and utility assistance who find themselves on the verge of homelessness, especially those who own their homes. I want to make sure that there is awareness for many veterans who do not engage with the VA for a lot of different reasons. We need to look outside the VA and other community-based organizations that may interact with veterans who are not connected with the VA but still need support and assistance. I am happy to have more ongoing discussions about that, and I look forward to speaking more with you about decreasing homelessness in Franklin County.
