MINUTES OF GENERAL SESSION

November 8, 2022

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room, at 9:00 A.M. on Tuesday, November 8, 2022.

Commissioner Crawley called the meeting to order at 9:10 A.M.

Commissioner Crawley: Today is November 8, 2022, so Happy Election Day and Happy Voter Day. I hope that everyone has either already made it to the polls or has a voting plan for today if you did not vote early.

Commissioner Crawley: November is Native American Heritage Month. Our friends, Ty and Masami Smith, directors of the Native American Indian Center of Central Ohio, had wanted to be with us this morning to celebrate Franklin County's Native American history, but due to family obligations in the Pacific Northwest, they are unable to attend today. We will be sure to invite them another time. For today, they sent a short video for us to play about one of their most important initiatives. This initiative is known as Land Back NAICCO, which aims to secure property in Ohio that would be exclusively devoted to Ohio's Native American heritage. Home care for the elderly and chronically ill provides a high-quality, compassionate way to age in place, and professional home health visits can reduce hospital readmissions by as much as 25%. Hospice is compassionate, person-centered end-of-life care that focuses on the comfort of the patient and the needs of loved ones. More than 1.5 million Americans receive hospice care each year, and we partner every November with the hospice organizations from OhioHealth and Mt. Carmel Health on an important event to celebrate and support their work. We'll have some light refreshments and entertainment, and you can purchase an ornament for the hospice tree in memory of a loved one who's no longer with us. It's a great fundraiser for the hospices and a poignant kickoff to the holiday season, so I hope to see you there.

Commissioner Crawley: November is also National Alzheimer's Awareness month and National Diabetes month. Alzheimer's is a type of brain disease that is caused by damage to nerve cells in the brain. It's the most common cause of dementia. It results in progressive memory loss and is ultimately fatal. More than six million Americans and their loved ones are living with Alzheimer's today, a number that will increase as our population ages. Diabetes occurs when a person's glucose, or blood sugar, is too high, and it affects about 37 million Americans. Resolution No. 0821-22, authorizing an Affordable Housing Development agreement with Woda Cooper Companies, Inc., to receive funding through the Magnet Fund Program to assist the development of an affordable housing project (\$850,000.00) (Economic Development and Planning), presented by James Schimmer, Director, Economic Development and Planning.

Mr. Schimmer reviewed information found in documents submitted with the proposed resolution.

Commissioner Crawley: Is there a minority participation goal for the project?

Mr. Schimmer: We do not have that in our contract.

Jonathan D. McKay, Vice President of Development, Woda Cooper Companies, Inc.: That is something that we do not have inked at this time, but it is obviously something that we always pursue with any development to meet Section 3 requirements because the project is located in the city of Columbus.

Kenneth N. Wilson, County Administrator: Mr. McKay, can you spell out what those requirements of Section 3 are?

Mr. McKay: It means that for a certain percentage of the project, we will be looking for different contractors and subcontractors that will reflect the minority participation.

Mr. Wilson: Is it an open percentage amount, or is there a minimum minority participation percentage that has been set for the development of these units?

Mr. McKay: We typically try to hit ten percent, and that is the goal for this project. We will try to exceed that goal if possible.

Commissioner O'Grady: Director Schimmer and Mr. McKay, we have been down this road for a number of years now, so I would expect that when these come before us, this question should be easy to answer. In the future, this should be an easy answer, and we should not need to have questions about this.

Commissioner Crawley: I asked this question because I was asked this question. People do look at the agenda that we publish, and there are folks who call in to inquire about something that we are about to vote on. I was asked what the minority participation is for this agreement. I know what Section 3 is, but it is important for the community to understand what Section 3 is or what the goal is for all projects regarding minority participation.

Mr. Wilson: We are proud of the accomplishments of the Magnet Fund, and in this community, we need all of the affordable housing we can get. When this agenda was published, I was also asked who would be developing and building these projects because there is a desire in the community for inclusivity. Even though we welcome every single affordable housing unit, minority participation, women participation, and diverse participation are extremely important. Has the construction manager been selected for this particular project?

Mr. McKay: Yes, it has. Woda Cooper is a vertically integrated affordable housing developer, contractor, and manager. So, we have a contracting arm that will be the contractor for this project. Woda Construction, Inc. is the name of it.
