MINUTES OF GENERAL SESSION

November 22, 2022

The Franklin County Board of Commissioners convened in the Commissioners Hearing Room, at 9:00 A.M. on Tuesday, November 22, 2022.

Present were: John O'Grady, Commissioner Kevin L. Boyce, Commissioner

Commissioner O'Grady called the meeting to order at 9:10 A.M.

Approval of the minutes for the November 8, 2022, General Session; the November 10, 2022, Voting Session; the November 17, 2022, Briefing Session; the October 26, 2022, Administrative Briefing Session; and the November 14, November 15, and November 16, 2022, Budget Hearings. Commissioner Boyce moved to approve the minutes, seconded by Commissioner O'Grady. The minutes were approved by roll call vote.

Resolution No. 0871-22, authorizing the settlement, for the amount of One Hundred Ten Thousand Dollars (\$110,000.00), of a disputed bodily injury claim asserted against the County by Michael Hamilton arising from an automobile accident and involving a Franklin County Sheriff's Deputy (\$110,000.00) (Prosecuting Attorney), presented by Jesse Armstrong, Assistant Prosecuting Attorney, Prosecuting Attorney's Office.

Mr. Armstrong reviewed information found in documents submitted with the proposed resolution.

Commissioner Boyce moved to approve Resolution 0871-22, seconded by Commissioner O'Grady. The Resolution was adopted by roll call vote.

Resolution No. 0872-22, authorizing non-general fund supplemental appropriations to support mental health, alcohol, and other drug treatment and prevention services (\$2,648,170.00) (Alcohol, Drug & Mental Health Board), presented by Allison Watters, Senior Finance Director, Alcohol, Drug & Mental Health Board.

Ms. Watters reviewed information found in documents submitted with the proposed resolution.

Commissioner Boyce moved to approve Resolution 0872-22, seconded by Commissioner O'Grady. The Resolution was adopted by roll call vote.

Resolution No. 0873-22, authorizing contracts with Enterprise Fleet Management, Inc. and Geotab USA, Inc. for the purchase of in-vehicle telematics devices in order to upgrade the County's vehicle telematics system installed on County owned or operated vehicles (\$200,000.00) (Fleet Management), presented by Charlotte Ashcraft, Director, Fleet Management.

Resolution No. 0874-22, authorizing a contract with The Ohio State University for the purpose of conducting expert analysis of the Ohio Behavior Risk Factor Surveillance System ("BRFSS") Intimate Partner Violence ("IPV") and firearm safety data collected to be made publicly available for the benefit of Ohioans in connection with the Blueprint for Safety Initiative (\$15,000.00) (Justice Policy and Programs), presented by Melissa Pierson, Chief Operating Officer, Justice Policy and Programs.
